3 Range

Community may include but is not limited to – a community of interest, a community of locality, a cultural community, a youth culture.

A *community profile* may include but is not limited to – cultural structures and organisations, families, groups, key people, networks, organisations, power structures, problems, needs, resources; whānau, hapū, iwi; youth cultures.

4 Definitions

Key people are those within a family or whānau, hapū, iwi, group, agency, or organisation who have the authority or mana to speak on behalf of the community. Where applicable, key people include those that provide services to the community.

Youth or young person refers to people between 12 and 24 years old.

Youth culture is any culture a young person identifies with. A youth sub-culture is any group who self-identifies as a sub-culture.

Youth development refers to growing and developing the skills and connections young people need to take part in society and reach their potential.

Youth participation refers to involving young people, hearing their voice, and having their opinions given weight in decision-making about issues that affect them.

Youth voice refers to the actions of young people having a voice on issues that affect them.

1.4. A youth voice plan is prepared.

1.5 A youth voice plan is implemented.

Outcome 2

Support young people to profile a community and have their voice on a community issue relevant to them.

Performance criteria

2.1 A relevant and meaningful community issue is identified.

2.2 Reasons for profiling the community issue are explained.

2.3 A profile of the community issue is prepared.

Range may include but is not limited to – definition of community boundaries, identification of youth cultures, profiling methodology, resources required.

2.4 Community representatives, community boundaries, and sources of information are identified.

Range may include but is not limited to – books, cultural group records, electoral records, historical records, key people, kin group records, local authority records, newspapers, political organisation records, postal district records, research outcomes, statistical information.

2.5 Profile findings are verified with community representatives.

2.6 The community profile is used to determine and recommend opportunities for youth development in the community.
