Authoritative New Zealand first aid text books are credible published materials, with a reliable publication process, by authors generally regarded as trustworthy or authoritative in first aid as it applies in New Zealand.

1.2 Presenting conditions and the immediate response required are identified in terms of signs and symptoms.

Range breathing difficulty, reduced level of consciousness, serious

bleeding, seizures, fractures, burns, poisoning, anaphylaxis.

1.3 Resuscitation techniques are demonstrated for an infant and for a child.

Range CPR, management of choking.
