- Common stress behaviours in small domestic animals: vocalisation, trembling, aggression, hiding, or refusal to eat.
- Causes of stress: unfamiliar environments, separation from owners, loud noises, overcrowding, and handling by unfamiliar people.
- Principles of safe handling: appropriate restraint techniques, lifting methods, and use of carriers or cages.
- Essential equipment: leashes, harnesses, crates, and bedding.
- Dietary needs of small animals, such as cats, dogs, rabbits, and birds, including emergency feeding options.
- Housing considerations: ensuring adequate space, secure enclosures, ventilation, and protection from the environment.
- Waste management: safe disposal practices for litter, bedding, and food remnants in alignment with SOPs and local regulations.
