### Pārongo aromatawai me te taumata paearu | Assessment information and grade criteria

For assessment purposes:

- Assessment must comply with the latest version of the *First Aid as a Life Skill*, available from Toitū te Waiora at <https://toitutewaiora.nz/first-aid-as-a-life-skill/>
- Competence must be demonstrated in a simulated emergency situation which involves people with major injuries and a medical condition.
- Assessment must include a minimum of two persons affected by a first aid emergency situation.
- Assessment must be conducted against a variety of scenarios developed by the provider.
- Assessment criterion 1a must include assessment of situational hazards. These may include – but are not limited to – electrocution, bodies of water, fire, hazardous chemicals, biological risks, presence of bodily fluids, the weather, road traffic accidents, gas contaminated environments.
- Assessment criterion 1b must include at least one example of a medical condition from – severe allergic reaction, cold emergency, heat emergency, and at least two examples of a major injury from – chemical, electrical or thermal burns, gunshot, impalement, stabbing, crush injuries, amputations, head injuries, suspected spinal injuries, internal bleeding.

Definitions:

2. *Manage* refers to management of the entire emergency situation in addition to providing first aid. This includes the identification of and reaction to potential dangers for all people present.

**Ngā momo whiwhinga** | Grades available

**Ihirangi waitohu** | Indicative content

- Managing a major incident involving two or more people, identifying and managing dangers or hazards in an emergency scene or situation, using bystanders, and calling for help.
- First aid in hazardous situations – electrocution, bodies of water, fire, hazardous chemicals, biological risks, presence of bodily fluids, the weather, road traffic accidents, and gas contaminated environments.
- First aid for a major injury – chemical burns, electrical burns, thermal burns, gunshot, impalement, stabbing, crush injuries, amputations, head injuries, suspected spinal injuries, internal bleeding.
- First aid for a medical condition – severe allergic reaction, cold emergency, heat emergency.
